Dear Mr. Duff:

This will acknowledge receipt of your acceptance of a Canada Council Senior Fellowship, as well as your application for a travel grant. This latter has been approved and funds to cover one-way passage will be sent to you with the first instalment of the award.

Because plans of Senior Fellows will not always conform to the academic year, it has been decided to divide the \$4,000 award into three payments, the first to be forwarded approximately one month prior to date of sailing (or prior to date of going on leave of absence); the second on receipt by the Council of a request from the fellowship holder approximately four months after the first payment, at which time a brief interim report on his work should be forwarded; and the third, which will include return passage, on receipt of a further request from the holder approximately four months after the second payment.

The Council proposes to pay these funds into your bank account. It will therefore be appreciated if you will advise us as soon as possible of the name of your bank, the branch, and the number of the account.


Attention is called to the requirement that a final report will be asked on completion of the work for which the award has been made; and to the suggestion that fellowship holders would be well advised to obtain insurance against loss of effects, personal injuries, and sickness.

The Council has been informed by the Taxation Division of the Department of National Revenue that subject to the condition that in no case will the grants be made for any service to be rendered to the Council or anyone else, scholarships granted by The Canada Council will not be subject to income tax.

Will you please let us know the date on which you expect to go on leave of absence, so that payment arrangements may be set up; and keep us advised of any change in your address.

SENIOR FELLOWSHIPS

General Conditions

Scholarships, fellowships, awards and prizes are given to scholars, teachers, or workers in the arts, humanities or social sciences, and cover travel, study or work to be done, as the case may be, only in those fields. Senior Fellowships are not renewable.

Eligibility - Except in the case of Non-Resident Fellowships, applicants must be residents in Canada or Canadians living abroad.

Payment - Usually scholarships and fellowships will be paid by cheque quarterly, in advance, subject to the condition that the holder continue in his work.

Reports - Holders of scholarships, fellowships and other awards will be expected to make a brief interim report when the period of the grant is half-expired, and a brief final report on the work in which they have been engaged. Only a final report will be asked from holders of grants for periods less than six months.

Travel - Travel allowances are available to holders of Senior Fellowships, plus two-thirds of a wife's travel expenses if she is to accompany the applicant. Allowances will be on the basis of tourist fares by air and sea where available and first class lower berth for overnight journeys by rail. Applications for such allowances must be submitted on the form supplied by the Council. The travel grant for one-way passage will be forwarded with the first quarterly payment; the return travel grant will be forwarded with the final payment.

Other Income - If any additional payment is awarded or received from another source, this will be disclosed by the fellowship holder; when such a disclosure is made the Council holds itself free to reduce the amount of the grant.

Insurance - In the case of those going abroad on Canada Council fellowships, the Council requires that holders obtain insurance against loss of effects, personal injuries, and sickness. The holder must provide the Council with satisfactory evidence of sufficient coverage before the first fellowship payment is made. For those remaining in Canada, the Council suggests that fellowship holders would be well advised to obtain such insurance.

Announcement of Awards - Senior Fellowships will be included in the announcement of the Council's complete list of awards of scholarships and fellowships in the Spring of 1958. It is requested that in making public references to awards, recipients avoid any implication that the Council is responsible for or in any way endorses the projects which may be undertaken by fellowship holders.
